

## Privacy Statement of S.V. Muurvast

S.V. Muurvast respects the privacy of its members, in particular their rights regarding the automatic processing of personal data. We have therefore formulated and implemented a policy on complete transparency with our members with regard to the processing of personal data, its purpose(s) and the possibilities to exercise your legal rights in the best possible way.

### Article 1 - Legal definition

Party responsible for processing personal data: S.V. Muurvast, residing at de Hems 10, 7523NL Enschede, the Netherlands.

### Article 2 - The processing of personal data

1. Personal data means any information relating to an identified or identifiable natural person (data subject).
2. We try to keep the amount of personal data at the minimum and only collect personal information, which is absolutely needed. We process the following categories of personal data from you:
  - Name
  - Mobile phone number
  - Email address
  - Bank account
  - Name of the account holder
  - Date of membership
  - Date of membership termination

### Article 3 - Data collection

The information will be collected via a form, which will be send to you via email. This form has to be filled in by you and sent back the next possible date.

### Article 4 - Purpose of processing

We do not collect your personal information without a purpose. Your personal data are processed for:

Your mobile phone number will be used in terms of a common S.V. Muurvast WhatsApp group and whatsapp in general. These messages via WhatsApp will keep you updated about training changes, tournaments, social activities and other important announcements.

Your email address will be used to send you the S.V. Muurvast newsletter, which has the aim to keep you informed like the WhatsApp messages. However, there is the possibility to unsubscribe from the newsletter by sending an email to [secretary@svmuurvast.nl](mailto:secretary@svmuurvast.nl). Furthermore, your email address will be used in order to inform you about invoices

concerning the membership fees, the training fees and additional costs of social activities for instance.

Your bank account information will be used in order to invoice the membership and training fees as well as additional expenses we made for you.

The date of membership as well as the date of membership termination will be used by us for organizational reasons to have an overview of the amount of members.

#### Article 5 - Sharing personal data

We will only share your data with persons and organizations related to the University of Twente and Saxion, e.g. the Student

#### Article 6 - Registration and storage of personal data

Your personal data are recorded in an register and will be stored safely. Additionally, we will inform you if your data was hacked.

#### Article 7 - Your rights regarding your personal data

1. Pursuant to Article 13 paragraph 2 sub b GDPR each data subject has the right to information on and access to, rectification, erasure and restriction of processing of his personal data, as well as the right to object to the processing and the right to data portability.

3. Each request must be accompanied by a copy of a valid ID, on which you put your signature and state the address where we can contact you.

#### Article 8 - S.V. Muurvast Website

This privacy statement only holds for the website of S.V. Muurvast. It might be the case that this website contains links to other internet domains. In this case, the privacy statement does not apply anymore.

#### Article 9 Changes of the S.V. Muurvast Privacy Statement

In case of changes concerning the privacy statement, we will inform you about the changes.

#### Article 10 - Applicable Law

These conditions are governed by Dutch law. The court in the district where the collector has its residency has the sole jurisdiction if any dispute regarding these conditions may arise, save when a legal exception applies.
